FEES AND BILLING

- **Complete the form and return to the School as soon as possible to assure your child's space.**
 - Extended Day Program Payments: Payment schedule is to be selected from the options listed below in this contract.
 - The full contract fee is payable regardless of absence or dismissal.
 - See extended day program calendar for specific information about days and times the program is available and possible changes to those days and times based on inclement weather.
 - Students are expected to be picked up at their contracted time. The following late fees apply for any student picked up after their contracted time.:
 - First Late Pick Up: \$10 late fee for the first five minutes or any part thereof; and an additional late fee of \$10 per every five (5) minutes thereafter.
 - Second Late Pick-Up: \$15 late fee for the first five minutes or any part thereof; and an additional late fee of \$15 per every five (5) minutes thereafter.
 - Third Late Pick-Up: \$20 late fee for the first five minutes or any part thereof; and an additional late fee of \$20 per every five (5) minutes thereafter.
- All late fees will be charged to your FACTS account by the business office.
- Using the drop-in program on any day you are not contracted will be based on space availability *and requires prior approval*. A morning fee of \$15 and an afternoon fee of \$15 an hour will be charged with to your FACTS account. There will be no drop-ins on inclement weather days or noon dismissal days.
 - Changes made to the contract, excluding drop in days, during the school year will be honored, provided space is available. There will be a \$100 processing fee for each change made to the contract after September 30, 2026.
 - The School reserves the right to refuse admission or continued attendance in the program if payment of fees is not made when due.
 - Tuition policy regarding delinquent accounts apply to all Extended Day Program contracts
 - The School reserves the right to refuse admission or continued attendance in the program should student behavior become an issue. The following protocol shall be followed: First infraction – a meeting with the parents to discuss the behavior plus a one week suspension from the program. Second infraction – a meeting with the parents to discuss the behavior plus a two week suspension from the programs. Third infraction – a meeting with the parents to discuss the behavior and the student shall be dismissed from the program.
